President's Message

DIVERSITY, EQUITY, AND INCLUSION – DEI

My (Old) Truth:

Prior to April 26, 2023, when I heard the phrase “DEI,” I had a visceral reaction. Why? Because my *perception* was that it goes against *my* foundational principles of “diversity in thought, equality based on merit, and inclusivity of differing opinions.” Hang with me....

NABIP Initiative:

NABIP asked our Texas and Local Chapters to include DEI as a Board Position. I disagreed with this for a couple of reasons.

1. Boards struggle filling chairs with members who maintain an active participation for the entire term as is.
2. I perceive(d) DEI to have an agenda that goes against my foundational principles.

Then, because of two individuals, I woke up thinking: What if I changed my perspective on the second point? Would that result in the first point having a different outcome?

Two Conversations:

I have a Modified Truth that is a direct result from two short yet intimate conversations, one with a Dallas Board Member and a second with a South Texas Board Member, where I was given permission to be vulnerable, which allowed me the freedom to change my position.

It's important to note that my position changed because of meaningful dialogue. We did not shut the other down. We did not raise our voices or fists. Each afforded me the opportunity to listen, and respectfully took a minute to hear my truth –an insecure kid going to school on the other side of the tracks in Odessa, Texas as a minority in an all Hispanic and black school, sleepovers at the Mendozas who lived next door to a crack house and down the street from gangs, family members passed over for promotions despite being more qualified, my inability to get scholarships or financial aid despite being number 2 (out of 780) in my graduating class, and my livelihood threatened and relationships severed because I questioned the Covid mandates and stood against mandatory shot protocols.

Experiences & Opportunities:

My experience with DEI training is that diversity is based on melanin or identity, equity does not equal fairness or equality, and inclusion only happens if I share the same ideology as others. Then, on April 26, 2023, I had an epiphany: My past experiences should not be an obstacle to the Association's future opportunities.

My belief is that NABIP-Texas will implement a DEI program founded on common principles of stewardship, community outreach, and attractiveness. With those underpinnings, we will gain more members. With more members, board attrition will wane, and the Association will flourish. Thank you, my fellow members, for your grace in giving me the chance to change my mind.

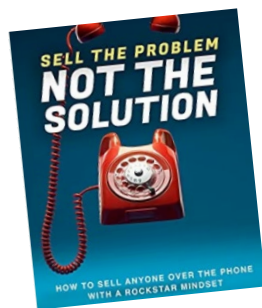

MEMBERSHIP BENEFIT HIGHLIGHTS



The Coronavirus Aid, Relief, and Economic Security (CARES) Act provided temporary relief during the pandemic by allowing Health Savings Account (HSA) qualified high-deductible health plans (HDHP) to cover telehealth services before reaching the deductible. It also allowed patients to choose and purchase telehealth services outside their HDHP, without impacting their eligibility for an HSA. This popular provision was set to expire at the end of 2022, but will now remain in place through December 31, 2024 as passed in the end of year omnibus bill of 2022.

Without further Congressional action, employers will be required to charge employees more to access telehealth services, creating a barrier to care, including mental health treatment. In addition, this must be addressed before 2024, as health coverage is offered prospectively. There is already bipartisan, bicameral support again in Congress to provide flexibility for plans and employers to offer telehealth pre-deductible in HSA plans, the Telehealth Expansion Act of 2023 ([H.R. 1843/S. 1001](#)). It is vital that Congress make this provision permanent in order to maintain continuity to care, expand access to care and reduce out-of-pocket costs for millions of Americans.

NABIP PAC

NABIP PAC has a new name, but it remains committed to moving forward and fulfilling its mission to support candidates that support our industry. I'm writing today to explain what NABIP's political action committee is and how it operates.

What is the National Association of Benefits and Insurance Professionals Political Action Committee (NABIP PAC)?

- NABIP PAC is a separate segregated fund (SSF) that allows for political advocacy from the connected organization -- in this case, NABIP.
- For this reason, the PAC (candidate fund) is restricted to raising money from dues-paying members.
- PAC money is NOT tax-deductible. Contributions are not deductible for state or federal tax purposes.
- NABIP PAC has two different accounts:
 - **Candidate Account**
 - **Administrative Fund**

What is the Candidate Account?

- It is made up of individuals' contributions through personal credit cards or bank accounts.
- Funds from this account are given to political candidates, both challengers and incumbents, Democrats and Republicans.
- NABIP members, their spouses and NABIP staff can give up to \$5,000 each year (federal law).

What is the Administrative Fund?

- Businesses can contribute to the Admin Fund.
- State and local chapters can also contribute.
- Money in this account goes to the operating costs of NABIP PAC so that the Candidate Account can be reserved solely for political contributions.
- Unlike the Candidate Account, there are no contribution limits on the Administrative Fund.

How does the NABIP PAC money we donate get spent by candidates?

- Winning Senate candidates spent an average of \$16 million in 2022.
- On average, \$2.0 million was spent to win a House seat in 2022.
- A NABIP PAC donation of \$2000 is just one in 2000 groups of people contributing to total amount needed to win that House seat.
- Needless to say, members of Congress have many groups like NABIP that expect their legislative agendas to become a priority through their donation.
- Through NABIP PAC, NABIP gets time and access to members of Congress to advocate on behalf of agents and brokers.

What are the rules for communication of available money for Candidate Account Fund?

- A member of Congress and his or her staff are never allowed to discuss the campaign or fundraising while using government resources. This includes in their office, while they are working on a Congressional activity, or using an email or phone number provided by the member's office.

The Texas House of Representatives passed its first “Local” Calendar on Friday - meaning it sent the first group of bills they finished debating over to the Senate side for more of the same. Remember that Schoolhouse Rock video you watched as a kid - "I'm just a bill..."? Turns out it was spot on! Both chambers must hear all bills in committee, then vote to approve them as a whole. Then the Governor gets to sign, veto, or just allow it to pass. Here's a detailed list of our top 30 bills we are tracking and where they are in the process. Some are clearly stuck (referred to but not heard yet by Committee). Some are well on their way (passed by the full House and referred to the Senate). We are down to around forty days left in the process, so the clock is ticking.

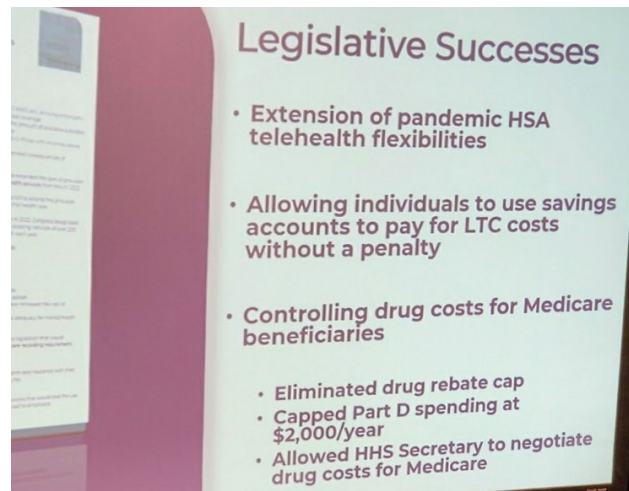
